MEMBERSHIP GUIDELINES:

1. Annual dues effective March 15, 2018 are \$10.00 (payable to Glacier View Lodge Society). Please include your payment when you submit the application form. New application forms can be submitted in person or via email to reception@glacierviewlodge.ca.
2. Payment is accepted in the form of cash, cheque or e-transfer to reception@glacierviewlodge.ca Please note: you must indicate in the **Message** field of the e-transfer the **name** of the member dues are being sent.
3. New members must be a member of the society for a minimum of 30 days before they can vote at the Annual General Meeting or Special Meetings. These new members are welcome to attend as non-voting members.
4. A person who has been appointed by the board as a board member is automatically entitled to join the society respecting the exclusions stated in the Constitution and By-laws.

EXCEPTIONS TO MEMBERSHIP:

1. No immediate family member (spouse, partner, child, or parent) of a current staff member of GVL shall be eligible for membership.
2. No person who is resident in or receiving care from a facility operated by the Society shall be eligible for membership. The provisions of this clause shall not apply to a member of the society who subsequent to becoming a member requires temporary care from the facility for a period not exceeding one year.
3. No employee of the Society or facility operated by the Society shall be eligible for membership- including medical personnel or suppliers of goods/services to GVL.
4. No person under 19 years of age shall be eligible for membership.
