Enhancing Care

Adult Day Program

The Adult Day Program continues to be a place of laughter and friendship, thanks in a large part to Liz's team of Kathy, Jessica and new team members Kim and Wayne. It is amazing to watch our clients care and support each other and to engage actively in each day's activities. The program continues to operate 7 days/week. Attendance over the year has continued to grow, although our global awareness of remaining home when we feel even the slightest bit unwell, has not allowed us to stay at full capacity. In 2023 we have begun oversubscribing the program by 50% in order to achieve our intended daily attendance.

The Supper Club, a caregiver education and support program, now is led by Recreation Therapist Rachel Little, ably supported by staff member Jessica.

Building a Community of Care

Replacing the 21-year-old accessible bus

One of the big fundraising initiatives for this year has been to secure funds to enable us to replace our 21 years old accessible bus. Enormous thanks to the CV Healthcare Auxiliary for their gift of \$75,000 which represents 50% of the cost of the bus. Our grateful thanks also to Peninsula Co-op for their gift of \$10,000 and to all those who have donated to the 2022/23 Legacy of Light Fund.

Screening

Over the past year, our versatile little Screening department has adapted to rapid testing visitors at the end of Wing 1, to coaching visitors to rapid test themselves, to supporting all visitors back to the Lodge – provided they are symptom free. The team has accommodated the changing long term care mandates as they came with flexibility and endless patience.

In addition to screening and welcoming our families, Screeners have been a wonderful resource to our team by performing regular hand hygiene audits, supporting tea and coffee in the afternoons and evenings, visiting with our residents who need one to one support, organizing our outbreak supplies (and other clutter), and helping other departments as able.

Music Therapy

Our lovely Music Therapist Bethany worked with us until the end of March 2023. We wish her all the best on her maternity leave with her new daughter. We are very grateful to the Fund Development & Communications Committee for spearheading the annual fundraising event, The Grand Parade, which largely funds the ongoing costs of enhancing our resident's quality of life through Music Therapy.

Our ongoing thanks to Breanna Brosko and her family for hosting the Adopt a Senior at Christmas program and for the additional gifts for those without families from IG Wealth Management. We are also grateful to the Soroptimist International of Courtenay for their annual gift to the Legacy of Light fund.



Coffee Parties

Two successful Purdy's Chocolate fundraisers have allowed us to purchase a fancy coffee machine for our bi-weekly Coffee Clubs and to purchase local coffee beans for the coming year. Residents and families are welcome to visit the coffee shop during opening hours on Wednesdays and Saturdays to pick up an espresso, latte, or americano (to stay or go).

Interior Redesign

While the full Interior Re-design project has not yet begun, we did purchase some new lounge furniture for our special care unit and purchased new resident room drapes. The new curtains have now arrived in multiple colours for residents to pick from!

Tovertafel

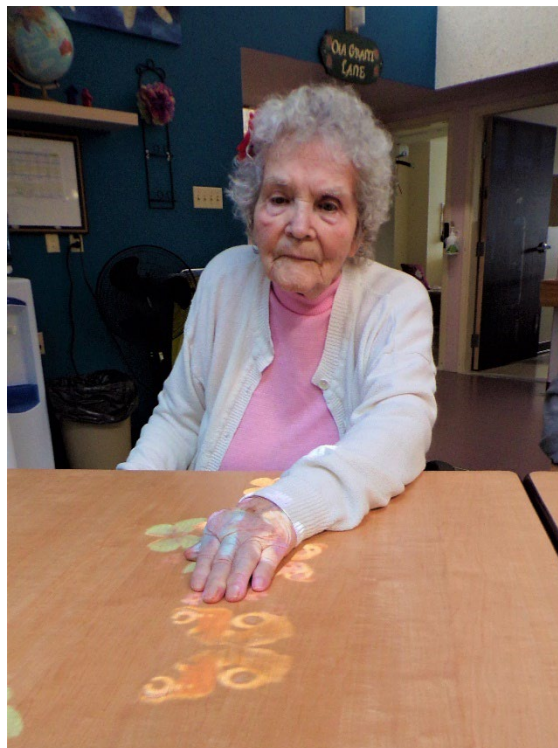
Thanks to the CV Community Foundation Grant

The introduction of the Tovertafel technology (interactive gaming system developed specifically for those living with neurocognitive disorders) was so successful that we began searching for ways to purchase additional machines. We extend our grateful thanks to the CV Community Foundation for applying for a grant on our behalf which has allowed us to purchase two additional units!

The Comox Valley Community Foundation continues to look for opportunities to support the Lodge – gifts for staff and isolated residents, along with treats at Valentine’s Day were very much appreciated!

The game projects images onto a table or floor and reacts to even the smallest movement of the resident’s hand or feet. Games range from lovely sensory-based activities where you can sweep the leaves, sweep away clouds to see the stars, or more involved games such as playing soccer, whack a mole, or growing a ‘virtual’ garden.

The Tovertafel activates players and provides cognitive, physical, social, and sensory stimulation. It has been amazing to watch our residents reach out to interact with the game images for long periods of time, extending their usual attention span, and to hear the laughter as the games are played.

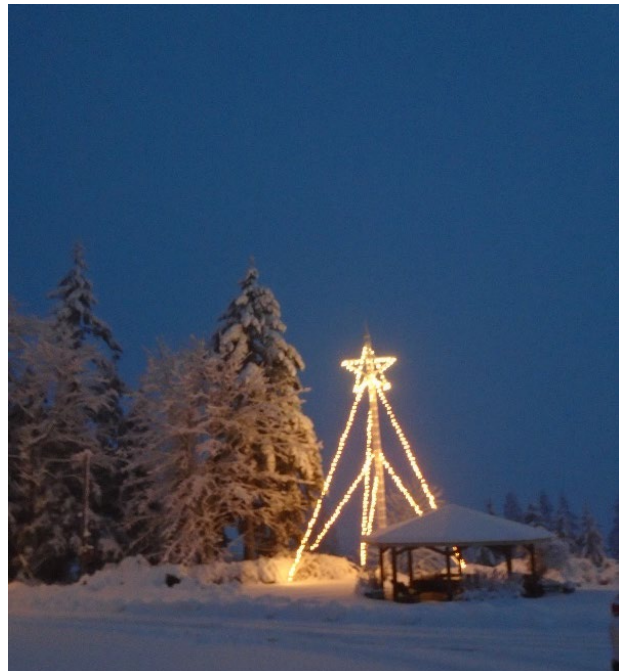

Strategic Priorities

1. Develop a plan to meet the housing needs of seniors for affordable, accessible housing on part of the undeveloped land owned by the Glacier View Lodge Society.
2. Enhance and sustain the long-term financial plan for the future of Glacier View Lodge.
3. Engage the broader community in helping to support Glacier View Lodge initiatives.
4. Improve the overall efficiency and effectiveness of the Board
5. Enhance and maintain the provision of exemplary care while addressing key elements such as quality, people, safety and risk management, and sustainability and innovation.
6. In recognition of the long-term contribution GVL has provided to the community, sustain, and enhance the capacity of Glacier View Lodge to provide exemplary complex care and community programs.

Building Maintenance Committee

The first two stages of the roof replacement, as recommended by IRC, have now been completed by Nelson Roofing within budget. Work on the third phase will begin in October 2023.

The upgrade to the air circulation and heating and cooling system in the common areas of the lodge has also been completed. The importance of this work has become apparent over the past year as the Lodge had to cope with heat waves and severe cold, as well as the expectation that every year may bring weeks of smoke from wildfires.

The committee continues to be aware of the challenges that come with an aging building, changing weather patterns causing more extreme weather, and the need to maintain an adequate level of replacement of aging technologies as new technologies become the preferred method of conducting the work of the Lodge.

To that end, the committee has also heard from and consulted with the Executive Director regarding the upcoming upgrading and replacement of the phone and wifi systems.

And of course, the committee remains focused on the smaller but equally important aspects of building and property maintenance like the resuscitation of the old exterior benches and improvements and care for the landscaping.

The committee discusses ongoing ethical challenges and debriefs respecting ethical challenges that have been addressed by staff. Key goals of these discussions are to determine how the challenges were addressed, whether ethical decision making followed organizational guidelines and how well those guidelines applied to the situation and whether they provided a useful framework to assist decision making through each dilemma.

On September 17, the Fund Development Committee, with Board approval, once again held The Grand Parade, a peer-to-peer fundraising event. The event was in person and held at the Comox Marina Park. We were exceptionally pleased to have received such generous corporate and community support resulting in raising \$54,401. Thank you to all our corporate sponsors, donors, friends, and family for making this such a highly successful event! A thank you reception for our key sponsors was held in November. Our music therapist, Bethany, held everyone's attention as she spoke about the benefits music brings to our residents. Funds from The Grand Parade were directed to the Music Therapy Program and Property Development.

Our Legacy of Light campaign, primarily focused during the Christmas period, but with reminders throughout the year during other special times - Valentine's Day, Mothers Day, Fathers Day - was also very successful, bringing in \$55,000. Funds raised went towards the Interior Re-Design project.

We have developed a closer relationship with the Comox Valley Healthcare Foundation, and we are finalizing details before signing a Service Agreement with them, allowing us to share their database system for our donors.

Finance Committee

The finance committee meets 10 times per year to review current financial information.

Annual audit done by KMPG, Chartered Professional Accountants.

Current Financial Position as of March 31, 2023

- An extremely challenging fiscal year due to Covid-19 and ongoing staffing issues.
- Operating loss/deficit of \$220,900.
- Total loss/deficit of \$220,600 (after investment and capital asset items).
- Primary factors contributing to loss are ongoing staffing issues leading to more overtime and orientation/training costs, vacant beds/co-pay loss & cost increases due to inflation.
- Cash on hand decreased by \$882,000 from \$2,740,300 to \$1,848,300. The decrease includes significant amounts spent for capital projects (roof and ventilation/hvac system).
- Investment account (equities and fixed income but excluding cash in the account) at March 31/23 was \$996,700 versus \$973,900 at March 31/22.
- Highlights fiscal year ended March 31, 2023
- 2022/2023 Covid & social visit funding of \$447,400 was received to cover expenses of an equal amount.
- Adult Day Program back in operation; ADP surplus of \$104,800.
- Required Direct Care Hours for Residents of 3.36 has been exceeded throughout the fiscal year.
- The management team has kept the overtime and sick time close to budget.

On-going challenges

- Significant future financial and operational challenges are expected due to staffing and Covid related issues.

Enhance The Long-Term Financial Future

Goal – A reserve fund, separate from our severance and disability fund.

- Investment balance (see above) includes approximately \$350,000 of our severance and disability fund.
